KISS 103.1 "THE F.O.R.C.E LIVE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WLXC-FM ("Station"), owned and operated by Cumulus Radio LLC, 1301 Gervais Street Ste. 700 Columbia, SC 29201, during available business hours Monday through Friday, on the Station website www.kiss-1031.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KISS 103.1 "The F.O.R.C.E LIVE TICKET GIVEAWAY" Contest** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. **Contest Period.** The Contest entry period will begin at 8:30 am ET on Tuesday, April 26, 2022, and will run weekdays from 11:30 pm ET until 2:30 pm ET through Monday, May 1, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter. Listen to the Station during the Contest Period. Between 8:30 am ET and 2:30 pm ET each weekday (each, a "Selection Day"), when the Station plays the cue to call sounder, listeners must call the Station at 803-695-5477. Caller number ten (10) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.
